# ASHLAND COUNTY CLERK OF COURTS COURT-ORDERED TITLE INSTRUCTIONS AND FORMS PACKET

If the evidence of ownership of a motor vehicle, outboard motor, or watercraft is insufficient for the issuance of a Certificate of Title to the current owner by the Ashland Count Clerk of Courts, the current owner may petition the Ashland County Court of Common Pleas for a court-ordered Title pursuant to Ohio Revised Code Section 4504.10.

\*YOU MUST BE AN ASHLAND COUNTY RESIDENT OR BUSINESS TO AVAIL YOURSELF OF THIS PROCEDURE. If your vehicle is self-assembled, rebuilt, does not have a VIN/has more than one VIN, or the VINs on the vehicle and Title are mismatched, you <u>cannot</u> use this procedure to obtain a Title. If your watercraft does not have a 12-digit HIN, or the HIN on the boat or motor does not match the HIN listed on the Title, you <u>cannot</u> use this procedure to obtain a Title.

It is strongly recommended that you consult with or hire a licensed attorney before proceeding.

#### STEP 1:

If you have not done so already, make your written request for a Title to the last-recorded owner and active lienholder of the vehicle or watercraft. Send your request via trackable means, such as US Certified mail, return receipt requested, and make sure you provide your full contact information in the letter, including a telephone number and e-mail address. Keep a copy of your demand letter and any return receipt cards (commonly known as the "green card") or electronic receipts, as well as any returned envelopes from failed, refused, or unclaimed mail.

If you don't have the name or address of the last-recorded owner and/or active lienholder, please visit the Ashland County Title Division of the Clerk of Courts. A deputy clerk will be able to assist you in obtaining this information via a records search providing the vehicle was previously titled in Ohio.

## Step 2:

Complete an Ashland County Clerk of Courts Auto Title division Record Sufficiency Form and take it to the Auto Division, Ashland County Clerk of Courts. A deputy clerk will complete and sign Section 2 and return the original to you. You will need this form when you file your case with the Legal Division of the Ashland County Clerk of Courts.

Forms are available on the Clerk's website: <u>www.ashlandcounty.org/clerkofcourts</u> or you can pick up the form in person in the Title Division.

## Step 3:

You will need to complete a Petition for Court-Ordered Title. Attach the original Title Division Record Sufficiency Form, copies of all of your documentation showing the efforts you made to contact the last-recorded owner and active lienholder for a Title, and copies of all additional paperwork you have to support your claim of ownership to the motor vehicle, watercraft, or outboard motor, such as a notarized bill of sale, manufacturers certificate of origin (MCO), and/or Certificate of Title. The fee for filing a Petition for Court-Ordered Title in Ashland County is \$80. This is a filing fee and is non-refundable.

Bring all of this information with you to the Legal Division of the Ashland County Clerk of Courts, located on the top floor of Ashland Common Pleas Court, 142 W. Second Street, Ashland, Ohio. A deputy clerk will file your documents and give you a receipt once you pay the \$80 fee. The deputy will assign a case number and make a copy of your paperwork for your records.

### STEP 4.

The Court will schedule a hearing on your Petition and send you a notice of the hearing. YOU MUST ATTEND THIS HEARING. This is your opportunity to explain to the Court why you are requesting a certificate of title.

The Judge or Magistrate will listen and may also have questions. Before the hearing concludes, the Judge or Magistrate will explain what will happen next. Pay careful attention and be prepared to complete any tasks, file additional documents, or attend any further hearings the Court requires.

## STEP 5.

If the Court decides to grant your petition, you will receive a certified copy of that court order from the Clerk's Office. It is important that you read the order and follow its instructions so that you can obtain your title. If the Court denies or dismisses your petition, you will not be able to receive a court-ordered title.

Neither the Clerk's Office nor the Court can provide you with legal advice. It is your responsibility to present your case to the Court. Even if you are not an attorney and choose to represent yourself, you are charged with knowledge of the law, the Rules of Civil Procedure, and the Court's Local Rules.
